



Q & M DENTAL GROUP'S JOINT VENTURE PARTNER IN NANJING OPENS NEW DENTAL CENTRE

- Dan De dental group launched its first dental centre in the PRC on 2 January 2011
- New 5,000 square feet dental centre in Nanjing city is strategically located at the prominent Greenland Square Zifeng Tower, the tallest building in Jiangsu province
- Modern facilities and sophisticated dental healthcare services to serve the fast growing upper middle- to high-income population

Singapore, 5 January 2011 – Mainboard-listed **Q & M Dental Group (Singapore) Limited** (“Q & M Dental Group” or the “Group”), the largest provider of private dental healthcare services in Singapore, today announced that its joint venture partner, Dan De dental group has opened a new dental centre in Nanjing city (“Nanjing Dental Centre”), the capital of Jiangsu Province in the People’s Republic of China (“PRC”). The Nanjing Dental Centre, which displays both the “Dan De (丹德)” and “Q & M (全民)” logos, commenced operations on 2 January 2011.

The Group’s joint venture company with Dan De dental group, Q & M Dental (Shanghai) Pte. Ltd. (“QMDS”), provided advice and expertise to Dan De dental group for the set-up of its first dental centre in Nanjing. Q & M Dental Group (China) Pte. Ltd., the Group’s 99%-owned subsidiary, holds 50% interests in QMDS.

With a floor area of approximately 5,000 square feet, the Nanjing Dental Centre is located on the fourth floor of the Greenland Square Zifeng Tower (绿地广场紫峰大厦) (“Zifeng Tower”), which is a new development comprising a mix of offices, hotel and high-end retail stores. Standing 89-storeys high, Zifeng Tower is the tallest skyscraper in Jiangsu province and the third tallest building in the PRC.

The Nanjing Dental Centre will cater to the rising demand for convenient, high quality and modern dental healthcare services as the base of upper middle- to high-income consumers in the city continues to expand quickly.

Boasting state-of-the-art dental technology such as the Galileos Cone Beam 3D Radiography, CEREC CAD CAM, MCXL Miller Machine, dental laser and other advanced dental equipment, the Nanjing Dental Centre offers multi-disciplinary dental healthcare services at one location including specialist services such as ‘one-hour’ dental crown, dental laser treatments and dental implantology.

The Nanjing Dental Centre is also designed to ensure a quality experience for its customers. In addition to stylish interiors, the dental centre has eight spacious private consultation rooms, each measuring around 200 square feet in size. The dental centre also has a fully equipped 35-seat auditorium to enable the Group to run training programs for dentists and dental surgery assistants.
