EXPANSION OF DENTAL CLINIC NETWORK IN SINGAPORE

The Board of Directors of Q & M Dental Group (Singapore) Limited (the "Company" and together with its subsidiaries, the "Group") is pleased to announce that it has opened three (3) new dental clinics which will widen its island-wide network to forty five (45) clinics, two (2) Dental Centres and one mobile dental clinic, and further entrench the Group's position as the largest provider of private dental healthcare services in Singapore.

On 28 September 2011, the Group commenced operations of a new dental clinic at 177 River Valley Road #B1-06A, Liang Court, Singapore 179030. This is the Group's first outlet in the River Valley area and will cater to the residents and office crowds in the surrounding precinct.

The Group also commenced operations of its second outlet in Bukit Batok on 7 October 2011. Located at Block 151, Bukit Batok Street 11 #01-248, Singapore 650151, this new regional dental clinic has 6 treatment rooms equipped with advanced dental technology so as to cater to the growing demand for high quality dental healthcare services in the Bukit Batok area.

At the same time, the Group established a new presence with the opening of its first clinic in Holland Village area on 8 October 2011. Situated at 200 Holland Avenue #B1-19, Holland Village MRT Station, Singapore 278995, this new clinic will strengthen the "Q & M" brand name with both expatriate and local communities in the vicinity.
