Q & M adds National Taxi Association to growing list of clients

- Affordable basic dental treatment for taxi drivers and their immediate family members

Singapore, 23 March 2012 – Q & M Dental Group (Singapore) Ltd (全民牙医集团 (新加坡) 有限公司), the largest private dental healthcare group in Singapore, has signed a memorandum of understanding with the National Taxi Association (NTA) to provide affordable dental care to its members and their families.

The pact, which will take effect immediately, will benefit 11,000 taxi drivers and their immediate family members. They get to enjoy quality and affordable dental care for two years with savings on basic dental treatments.

Q & M operates over 46 dental clinics and four dental centers at easily accessible locations at HDB heartlands, MRT stations, and shopping centers. Q & M serves more than 400,000 patients and employs more than 150 dentists and 300 support staff.

“Taxi drivers are the first few faces of Singapore that many tourists encounter. We aim to help you to show happy smiles to your customers,” Dr Ng Chin Siau, Q & M founder and group chief executive officer, said in his speech during a signing ceremony today with NTA.

Dr Ng added: “As an organisation focused on providing affordable and quality dental services to our patients, we work hand-in-hand with other self-help groups, trade associations, companies and unions who are keen on the well-being of their employees or members and their families.”

Currently, Q & M has approximately 300 corporate clients. These are expected to grow significantly into a sizeable chunk of the group's revenue in the near future.

“With the rising cost of dental care, we are now talking to various organisations to provide affordable basic dental care programmes to its members. It is noteworthy to state that NTA is one of the very first organisations to take lead in promoting the dental care of its members and we are proud to be their preferred dental healthcare partner in Singapore,” Dr Ng said.

Acting Minister for Community Development, Youth and Sports and Minister of State, Ministry of Information, Communications and the Arts, Major General Chan Chun Sing was present to grace the signing ceremony, along with Members of Parliament for Ang Mo Kio GRC, Mr Seng Han Thong and Mr Ang Hin Kee.
