SINGAPORE, 2 July 2020 - Q & M Dental Centre Pte. Ltd., a wholly-owned subsidiary of Q & M Dental Group, is pleased to announce a new programme to hire and train mid-career Dental Surgery Assistants.

Supported by Workforce Singapore (WSG), the Place-and-Train Programme for Dental Surgery Assistants will help lower the barriers to entry for new mid-career hires, who lacked relevant experience and skills, by equipping them with the necessary skills and competencies, thereby aiding their transition to take up new job as Dental Surgery Assistants with Q & M Dental Centre.

Through the programme, Q & M Dental Centre will be able to expand its workforce to support its growing operations. At the same time, the organisation also creates viable and meaningful job opportunities for local mid-careerists who are keen to embark on a new career in healthcare services. Up to 30 Singapore Citizens and Singapore Permanent Residents, who will be employed as Dental Surgery Assistants by Q & M Dental Centre, stand to benefit.

The three-month programme comprises classroom lectures as well as on-the-job practical training in various clinics under the Q & M Dental Group located around the country. Topics covered in the training programme include Dental Administration and Communication, Infection Control and Sterilization, Dental Charting and Chair-side Assisting, and Dental Radiology.

Q & M College of Dentistry, which has been registered with the Council of Private Education since June 2019, will be the training provider for the Place-and-Train Programme for Dental Surgery Assistants. Currently, the Q & M College of Dentistry also offers the Graduate Diploma in Clinical Dentistry course for practising dentists in Singapore.

Dr Ng Chin Siau, Q & M's Group CEO says: "As the leading provider of private dental services, we continue to expand our reach to cater to the increasing healthcare demands in Singapore. This also allows us to create job opportunities amidst the COVID19 pandemic.

The introduction of the Place-and-Train Programme for Dental Surgery Assistants is timely, will certainly support our manpower needs as demand for healthcare services in Singapore continues to grow. We also want to ensure that our new dental nurses would provide quality assistance to dentists by undergoing the programme, which provides a certifiable skillset from the largest private dentistry group in Singapore."
