Dr. Ng is a substantial shareholder of the Company by virtue of his deemed interest in Quan Min Holdings Pte. Ltd. ("QMH"). During the consolidation of records, it was identified that 8,600 ordinary shares in the capital of the Company held by QMH were inadvertently omitted from the disclosure made on 28 November 2025 and are now included in this disclosure. The omission does not affect the percentage shareholding interest previously disclosed. The delay in disclosure is unintentional. QMH and Dr. Ng were made aware of this omission on 9 January 2026.
